





Pursuing
green finance and investment
and ensuring **a just transition**

- Meeting the **additional investment needs**
- Proposal for a **Sustainable Europe Investment Plan** and a **Just Transition Mechanism (EUR 100 bn)** in January 2020
- **25% target for climate mainstreaming** across all EU programmes within the proposed MFF 2021-2027
- Proposed **new revenue streams** (“Own resources”) and review of the **Innovation and Modernisation funds** to deploy climate neutral solutions
- Mobilisation of **InvestEU** in support of the Green Deal objectives
- Work with the **EIB group (climate target to 50% by 2025) and other financial institutions** (NPBs, other int’l financial institutions)
- Renewed **Sustainable Finance Strategy** in Autumn 2020
- **Taxonomy, Corporate governance** framework
- Review of **Non-Financial Reporting** Directive
- Support **natural capital accounting**
- **Labels for retail financial investment products**
- Developing **EU green bond standard**; integration of environmental risks in **EU prudential framework**

Work towards 2030 targets, and a trajectory 2030-2050

- The Climate Law will eventually include the new 2030 target. The current proposal starts work towards it:
 - Asks the Commission to explore 50-55% by September 2020 – the Commission will propose to amend the law once the impact assessment is concluded.
 - Asks the Commission to make new sectoral proposals by June 2021.
- It tasks the Commission to establish a Union-wide trajectory 2030-2050 to be used to assess progress towards climate-neutrality.

Financing the Just Transition

In parallel to the Climate Law, the EU will support the transition with funding and financing tools:

● **The European Green Deal Investment Plan,**

- Unlock at least €1 trillion of sustainable investments over the next decade,
- The InvestEU guarantee will support this by de-risking finance and investment operations aligned with the EU policy objectives,

● **Renewed Sustainable Finance Strategy,**

- Ensuring that sustainable investments are mainstreamed,

● **The Just Transition Mechanism, and Just Transition Fund,**

- Support the most affected regions and sectors ensuring the transition is fair and leaves no one behind,
- Help to modernise and diversify economies and alleviate social and economic costs of the transition,



