Context of the seminar

The Final event of [THE NEXT SOCIETY](#) is organised by [ANIMA](#) with the support of [CONECT](#) in the presence of the European Commission (DG NEAR).

Since 2017, ANIMA and its partners have federated a community of innovators and tech hubs around the Mediterranean with the ambition to contribute to facing the challenges of this region, the cradle of modern civilizations. Mitigating climate change, fighting against social and territorial imbalances, supporting the rise of technology and creating the jobs of tomorrow. The name of this ambition and this community is deliberately immodest: THE NEXT SOCIETY.

After five years of collaboration, THE NEXT SOCIETY is proud of its impact.

Half of the 410 companies supported in Algeria, Egypt, Jordan, Lebanon, Morocco, Palestine and Tunisia have been founded or co-founded by women. 78 technological partnerships and business contracts have been signed, 22 of the supported start-ups have raised more than 2 million euros and 151 jobs have already been created. 50 technologies have left the South Mediterranean laboratories to be developed within the framework of industrial partnerships or new company creations.

50% of these start-ups mobilise technology for the common good by offering concrete solutions to the Sustainable Development Goals (SDGs) on hunger, health, education, environment and energy. Thanks to technology, these companies recycle waste or clothes, develop more efficient mobility, water or waste management solutions, rationalise the use of natural resources, detect childhood diseases or accelerate the dissemination of e-learning solutions.

THE NEXT SOCIETY is also at the origin of **new regulatory frameworks** that strongly accelerate innovation in several South Mediterranean countries: reform of the intellectual property regime in universities, support for the implementation of crowdfunding, adoption of tax measures that favour research in companies.

THE NEXT SOCIETY is the proof that the connected, collaborative and integrated Mediterranean basin can develop **solutions to these major regional challenges** and inspire others.

The final event of this project aims at promoting our collective impact after 5 years implementing this comprehensive initiative in Europe and the Mediterranean. We want therefore to build on that, wondering how to go further supporting innovation, setting up new and reinforced cooperation, explore common visions and seek new partnerships to better serve this amazing community.

The objectives of the meeting are:

- **Showcase the impact** of our action whether it be on start-ups, clusters, TTO or public strategies for innovation.
- **Capitalise on these results** for upcoming initiatives and discuss what these results tell us about how to sustain the region's ecosystems.
- **Identify actors or initiatives** able to take ownership of this work to extend its results locally and ensure direct follow-up with new EU regional programs.
- **Provide a business cooperation place** for innovation and industry players from EU and MENA countries willing to develop their international dimension.

After 2 years of online meetings, we hope that this event will be a good opportunity to gather the string arm of the community and build on the impact of THE NEXT SOCIETY to keep on promoting inclusive innovation and competitiveness in the Euromed region. These efforts will be extended through new opportunities gathered in a programme to be launched during this event: Euromed Cluster Forward.

Session 1: Technology upgrading and new regulations for efficient innovation support ecosystems

Chair: Mathias Fillon, Coordinator THE NEXT SOCIETY

In the context of a globalized economy plagued by shocks with worldwide resonance, the innovation developed in MENA countries - and even more so when it is frugal - does not make it possible to respond to the major global challenges, nor to those often common to the countries of the Mediterranean region. Indeed, the weakness of MENA ecosystems and the limited access to technology appear as important limits to the local potential for innovation that would come to "solve" the region's problems.

However, the region is seeing important progress, particularly at public strategies level, allowing for the adoption of necessary regulations – supported by the acceleration of digitalization - and incentive mechanisms for companies and investors that are supposed to boost innovation and competitiveness.

Through THE NEXT SOCIETY experience, this first session will present the regulatory efforts undertaken by the countries of the region - and their impact - to strengthen the competitiveness of their ecosystems and the technological upgrading of their companies, as well as the priority engagements that still should be made.

Session 3: Initiate Euromed value chains: the only way to put the Mediterranean on the map?

MENA countries are facing common problems for which the regional scale appears to be the most relevant to provide answers: climate change and pollution, external dependence of food security systems, the need for access to technology and EU markets... To face these various crises, Euromed cooperation appears to be the only way to rethink the structure of business partnerships of MENA countries and to progress towards the creation of a "Mediterranean pole" better able to control its economic destiny. But this presupposes a strong and open voluntarism on the part of the EU, without which the MED countries will turn to other partnerships and markets, not allowing a Mediterranean model to emerge.
