# 1. About EU-ALLIANCE project

The general objective of EU-ALLIANCE, co-funded by the COSME programme of the European Union, is to support SMEs internationalisation of six leading European clusters in the fields of technical textile, connectivity, deep-tech and advanced materials to address dual-use markets in four targeted countries: the United States, Canada, Japan and Indonesia.

The EU-ALLIANCE project is a follow-up of the successful activities implemented in the ALLIANCE Strand 1 project funded under the COSME programme. During the course of ALLIANCE project, the partners have signed one Memorandum of Understanding in the US and have developed close business relationship with several entities in Japan.

The key objective of EU-ALLIANCE is to help SMEs in the global competition in providing internationalisation-customized services to enter new international markets and in organising a delegation of SMEs supporting by the partners in the four targeted countries.

The expected results of the project are:

- Establishment of business agreements between European SMEs and international partners in the four target countries;
- Establishment of cooperation projects between the European SMEs and the international partners of targeted market;
- Animation of the cooperation agreements already established in the US and Japan.

# 2. The target market for this call: Canada

Canada is one of the founding members of NATO in 1949 and engaged in the world, with the Canadian Armed Forces through peace support operations and peacekeeping. Canada is committed to develop stronger relationships with other multilateral partners, such as the European Union. The defence and security industry contributes \$6.2B in annual GDP and 60,000 jobs to the Canadian economy. Thus, the Canadian defence and security market is mature and technology rich.

In relation to the textile sector, more than 8.400 companies are active in textile materials production in Canada, with a 56% specialized in technical textiles and 27% in other value-added textiles.

The dynamism of the aerospace and defence industries in Canada combined with its technical and connectivity textile markets makes it an ideal country to target, also considering the close relationship between Canada and Europe.





Some of the EU-ALLIANCE partners already have strong connections with Canadian institutions; this will permit an additional network to the existing one and new collaboration benefits for the European SMEs. The project will leverage and participate also to European matchmaking events supported by the ECCP.

Potential targeted partners include the Canadian association of defence and security industries, the CTT Group, the Canadian Textile Industries Association (CTIA), the Institute of Textile Science and more others to be contacted.

#### 3. The mission activities

While in Canada (Montreal and Ottawa), EU ALLIANCE will provide the participants with a series of activities to bring together SMEs and other stakeholders, with the high potentiality of collaboration in technological innovation and technology transfer.

The official mission will contain the following activities:

- B2B meetings with local companies
- Individual meetings with local stakeholders
- C2C meetings (cluster to cluster) and agreements signature
- Visit to companies, research labs, incubators or agencies/associations
- Visit to OPEX OPERATOR Expo (tbc)

# 4. Sanitary regulations

Selected SMEs to the mission to Canada refer to the EU-ALLIANCE cluster for the trip organisation and all other logistic arrangements. Local clusters will support the selected SMEs for the travel and logistics organisation.

#### 5. Terms of the call

This Call for EOI has the aim of selecting the SMEs that will participate in the international mission to Canada.

The EU-ALLIANCE Call for EOI is open to SMEs active in: Textile, Deep tech, Defence, Security, Maritime, Automatic & Robotic, ICT, Cybersecurity, Smart materials, PPE, Medical sectors willing to expand their business in the target markets of this call.

The main goal of this call is to support SMEs in networking activities, like B2B meetings, company visits, visit to relevant tradeshows/events, products showcase and other similar initiatives with the aim of creating cooperation and business opportunities.

EU-ALLIANCE will select SMEs based in EU

Being a member of one of the partners of EU-ALLIANCE clusters will be considered a rewarding criterion in the selection.

The financial support will cover part of the costs related to the travel to Canada.

# 6. Entry requirements

The applications submitted shall be approved according to the following criteria:

 Being a Small or Medium Enterprise as defined in the EU recommendation 2003/361 (<a href="https://ec.europa.eu/growth/smes/sme-definition\_en">https://ec.europa.eu/growth/smes/sme-definition\_en</a>)





- Having the headquarter or a branch office based in EU
- **SMEs must be active** in one of the following sectors:
  - Textile
  - Deep tech
  - Defence & Security
  - Maritime
  - Automatic & Robotic
  - ICT
  - Cybersecurity
  - Smart materials
  - PPE
  - Medical
  - Advanced materials
- Application must be written in English (applications partially written in another language are not eligible).
- Applicants must fill-in the Survey at the following link (Google form):

- Applicants have to fill in the EU-ALLIANCE .ppt template in English language available at the following <u>link</u> express their candidature, taking care to not exceed the maximum number of characters stated in each text box of the .ppt. Pictures/photos and diagrams are allowed and encouraged.
- Filled EU-ALLIANCE .ppt must be submitted via email to the address **jrafton@techtera.org** and by the deadline reported in section 5, with the object "EU-ALLIANCE\_Application\_Company".
- Each SME can apply for one or more international missions within EU-ALLIANCE project; if a SME has already participated in a mission and wants to participate to a second one, in the selection process, priority will be given to SMEs that have not yet participated.

The email receiving date and time will be considered as the submitting date. A confirmation e-mail will be sent as a receipt of application.

## 7. Evaluation criteria

All the applications will be gathered and assessed by TECHTERA with a first on rolling eligibility check. Submitted applications that passed the eligibility check will be ranked based on the scoring of the evaluation criteria set below and approved by the EU-ALLIANCE Evaluation Committee consisting of representatives of EU-ALLIANCE partners.

The applications submitted shall be evaluated on the basis of the following criteria:

# 8. Financial support

Selected SMEs will participate to the international mission to Canada with a financial support in form of lump sum **up to 1,000.00 Euro**.

Participants to the mission must provide evidence of their attendance to the EU-ALLIANCE international activities presenting boarding tickets, hotel receipts and any other document proving the effective participation.

Participants commit to provide some information as feedback on mission participation: business agreements, turnover modification following internationalisation mission, number of contacts, follow up activities, etc.
